### **NON-REFUNDABLE ANNUAL REGISTRATION FEE \$100 PER CHILD (\$150 FOR 2 CHILDREN)**

An enrollment fee equal to one half of your monthly tuition is due at the time of enrollment. This amount confirms your child's enrollment and is applied to your June 2026 tuition. The enrollment fee is non-refundable. Children holding a confirmed space in a fall class but unable to start on the first day of school will be responsible for the tuition from the beginning of the month.

### **TASSAJARA LEARNING CENTER IS CLOSED DURING SCHOOL AND LEGAL HOLIDAYS, GENERALLY FOLLOWING THE SRVUSD**

For the School Year, tuition is based on 10 equal installments. It has been calculated to account for vacation and holidays. There is no tuition reduction due to illness, vacation, holidays or any other absences. Two weeks written notice is required for withdrawal or schedule changes.
